- Assists in the implementation and evaluation of the annual Nutrition Education Plan.
- Maintains appropriate and timely nutrition education materials for client use.
- Provides ongoing nutrition education for staff.
- In collaboration with other WIC supervisors, oversees the daily operations of the WIC program in the Senior Director of WIC's absence.
- Conducts periodic audits to ensure that staff perform duties according to WIC policy and procedure.

- Previous supervisor experience required.
- A minimum of one year experience in maternal and child health or clinic setting with teaching responsibilities.
- If a Registered Nurse or Registered Dietitian, must be licensed in the State of Indiana.
- CPR certified.
